### The IL digital CCAP application at a glance

The Illinois Department of Human Services Division of Early Childhood (IDHS DEC) has partnered with Code for America to **build an online application for the Child Care Assistance Program (CCAP)** for families and providers.

#### Quick highlights of the digital application:

- Apply on any **smartphone**, tablet or computer
- Available in **Spanish & English**
- Takes **20 minutes or less** to complete
- **Accessible**, uses **plain language**, simple to navigate
- **Easy to upload** supporting documents



#### Benefits for providers

- More families will be able to complete the application independently, freeing up significant amounts of your time
- Families will email or text you a link that enables you to “respond” to their CCAP application remotely in 5 minutes or less
- Completed applications should contain the information required for eligibility determinations, reducing the number of requests for additional information (RAIs) and speeding up processing time
- The digital application is **accessible**. This means the experience is easy to understand for people of all abilities and education levels - including those experiencing trauma or stress, as well as users with low vision, hearing impairments, limited mobility, or sensory sensitivities
- Child care providers can also apply to become CCAP providers in 15 minutes or less

## Key things to know:

### ✓ Have a provider email address or mobile phone number to use for CCAP applications



- Decide if you prefer to use email or text message for digital applications
  - Families will contact you by email or text message. This will enable you to complete your part of the application and agree/decline to provide care
  - The decision to use email or text message may depend on whether you are a child care center or home-care provider
  - Share this email or mobile phone number with families when you speak with them

### ✓ The digital application is for new applications

- The [digital application](#) is for **new** CCAP applications
  - Redeterminations (REDE), Change of Information (COI), Change of Provider (COP), Requests for Additional Information (RAIs) need to be filled out using the appropriate paper form

### ✓ Know your Provider ID number

- This is an 8-15 digit number provided by the Illinois Department of Human Services (IDHS)
- You might also know this number as your CCMS ID or Child Care Management System ID
- Your Provider ID number is **not** your SNN, FEIN, or EIN numbers
- You can find your Provider ID number on the following forms:
  - CCAP Approval Notice (Form IL444-3455A)
  - Child Care Certificate/Certificate Report (Form IL444-3492)
  - Child Care Certificate Report for Centers (Form IL444-3492A)
  - Monthly Enrollment Report for Site Administered Providers

## How to complete the digital CCAP application

### Step 1: help families apply for CCAP online

- The digital CCAP application, [illinoiscaresforkids.org/applyforchildcare](https://illinoiscaresforkids.org/applyforchildcare), is currently available to families in 19 counties

- When you meet with families, let them know they can now **apply for CCAP online at** [illinoiscaresforkids.org/applyforchildcare](https://illinoiscaresforkids.org/applyforchildcare)
- Give families your provider email address or provider mobile phone number

### Talking points for speaking with families:

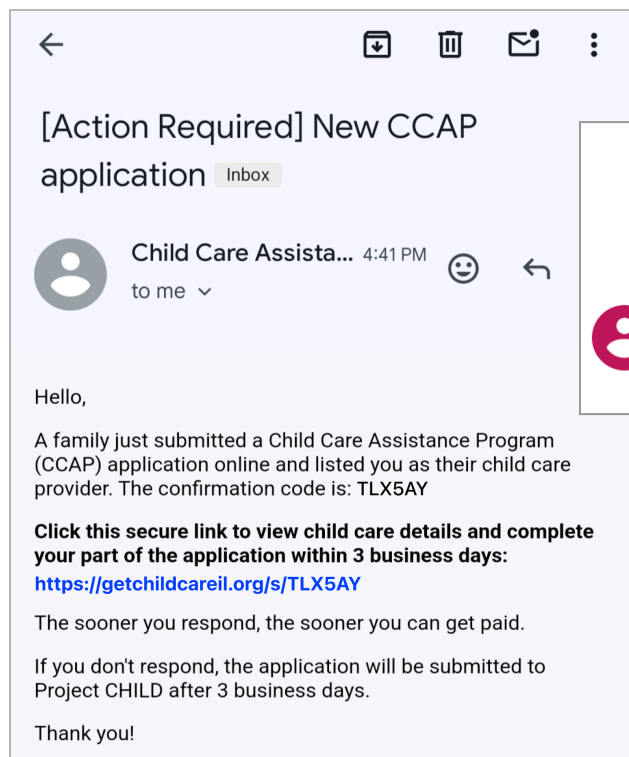
- ✓ Families can apply on a smartphone, tablet or computer in under 20 minutes
- ✓ It's easy to upload any supporting or eligibility documents
  - Families should try to have the needed eligibility documents ready before applying
  - Families can upload documents by taking a photo on their phone/tablet, or attaching saved documents
  - Families should be encouraged to upload their documents right away. If they don't have all the documents, they should still submit the application. An eligibility worker will reach out requesting any outstanding documents
  - Document files can be in these formats: .jpg, .jpeg, .png, .pdf, .bmp, .gif, .doc, .docx, .odt, and .ods files up to a maximum size of 10MB
- ✓ The digital application is available and accessible in Spanish and English. It's easy to switch back and forth between the two languages
  - Look for the **ENGLISH** **ESPAÑOL** buttons on every screen in the top right corner of the website
- ✓ Families will receive a confirmation email from [noreply@getchildcareil.org](mailto:noreply@getchildcareil.org) once they've completed the digital application

## Step 2: families contact their child care provider

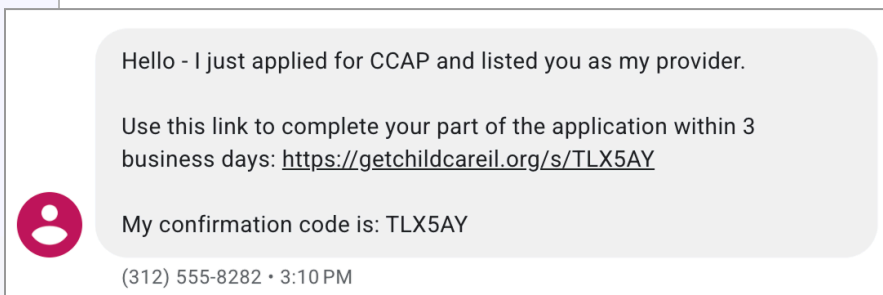
- As families apply online, they will be prompted to contact you by email or text message. This will allow you to “respond” to their application, and agree or decline to provide care

## Step 3: child care provider responds to an digital/online application

- If a family lists you as their chosen child care provider, you will receive an email from [noreply@getchildcareil.org](mailto:noreply@getchildcareil.org), or a text message directly from that family
- The email or text message will include a **secure link and a unique 6-digit confirmation code**
- Use the secure link to respond to the application. Or, you can go to [illinoiscaresforkids.org/applyforchildcare](https://illinoiscaresforkids.org/applyforchildcare) and enter their six-digit code at the bottom of the homepage where it says "Are you a child care provider?"
- You have **3 business days to respond** to an application
  - If you do not respond within 3 business days, the family’s application will be sent to the local Child Care Resource & Referral (CCR&R) agency for processing. You will still have to agree or decline to provide child care at a later date
- This process should take you **5 minutes or less**

## How to respond to a digital application:

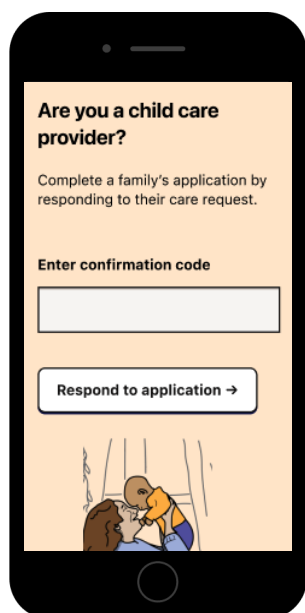
1. There are **two ways to respond to a family's digital application** and complete the agreement to care:

Either open the secure link you received in the email or text message

Or go to [illinoiscaresforkids.org/applyforchildcare](http://illinoiscaresforkids.org/applyforchildcare):

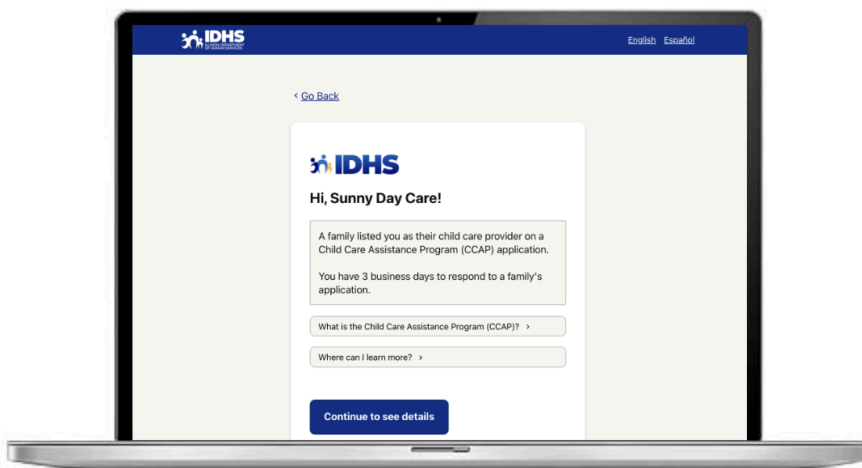
- scroll down to the orange section of the homepage, which says “Are you a child care provider?”
- enter the family's confirmation code
- click ‘Respond to an application’

On the next screen, click ‘continue to see details’ to begin responding to an application



*You can respond to an application by clicking on the link you received in the email or text message from the family. Or you can respond by going to [illinoiscaresforkids.org/applyforchildcare](http://illinoiscaresforkids.org/applyforchildcare) and scrolling down to the provider section and enter the confirmation code you received.*

*Once you're on the website, answer the questions to complete your part of the application.*



2. Enter your **Provider ID Number**
  - This is the 8-15 digit number provided by the Department of Human Services (IDHS)
3. **Verify or enter the confirmation number** you received in the email or text message
4. Fill out and confirm your provider information
5. **Respond to the application** (agree or disagree to provide child care)
6. When you're done you will receive a confirmation email from [noreply@getchildcareil.org](mailto:noreply@getchildcareil.org)

## Step 4: submission & processing of digital applications

- The family application, your provider response, and any supporting documents submitted by the family will be sent to the appropriate Child Care Resource & Referral (CCR&R) agency or Site Administrator for processing
- An eligibility worker will reach out to either you (the provider) or the family as needed
- To check on the status of an application, contact your local Child Care Resource & Referral Agency (CCR&R) or Site Administrator

## Bonus: register to be a CCAP provider

- Friends, family members, or neighbors that take care of someone's child, **can apply to become an eligible CCAP provider**
- If your child care center is unable to care for someone's child for any reason, you can let a family know this is another option for them
- Have the family fill out the digital CCAP application. When their chosen provider (friend, family, neighbor) responds to the application to complete the agreement to care, **they will be prompted to register for CCAP**
- This process should **take 15 minutes or less** for the provider to complete
